NOTES

1. Out of District, paid coaching experience, in a WIAA school program, shall be considered one to one for the same or similar positions, effective Dec. 1, 1998 for new hires. Coaches hired prior to Dec. 1, 1998 are grand fathered according to past practice. Out of state experience in a National Federation of State High School Association program shall be counted towards experience effective April 1, 2003.
2. Coaching experience at a lower level shall be considered as one year experience for every two years experience at the lower level if moving up to a higher position.
3. Drama is fixed at the following rate: (0.140 * Base) with the stipend to be divided between the participating directors.
4. The rate of pay for assistant coaches shall be two categories lower than the head coach rate.
5. The rate of pay for C-squad coaches shall be three categories lower than the head coach rate.
6. The rate of pay for assistant coaches in a 7-12 sports program shall be two categories lower than the high school head coach position for that sport.

Employees may elect to receive payment on one of the following bases:

1. A one time payment when the contract is complete; **or**
2. Equal monthly payments over the remaining months of their regular employment contract.
